







Glossary of Terms

Average Enrollment: The number of members enrolled during a given timeframe/number of months in that timeframe. Example: I was enrolled Jan-July, I would count as enrolled in each month, even if I started Jan 15 and termed July 2.

Average Family Size/Average Contract Size: Is the average number of members enrolled per employee.

BoB Benchmark: Meritain Health's Book of Business.

EE Cost Share: Represents the portion of the cost for the employee. It is calculated as (Out of Pocket) / (Plan Paid + Out of Pocket).

HEDIS: Healthcare Effectiveness Data and Information Set provides a national measurement standard for several cost, utilization and quality measures. These measurement methods are maintained by the NCQA (National Committee for Quality Assurance). Adherences to these guidelines allow health plans to compare performance results to national and regional benchmarks to improve performance.

Incurred Timeframes: Incurred timeframes report utilization based on the date the claim was incurred. This view is appropriate for utilization-based trends based on when the claim was incurred rather than paid.

Management Services: Fees such as state surcharges, shared savings fees, and case management fees charged by the hour (if applicable).

Marketscan Benchmark: Broader industry-based benchmarks based on Truven Health Marketscan data.

Member Months: The number of months a member (s) was enrolled during a given timeframe. Example: I was enrolled Jan-July, I would have seven member months.

Paid PMPM: The amount paid by the plan per member per month. It is calculated as "Paid / Member Months".

Paid Timeframes: Paid timeframes report financials based on the date the claim was paid. This view is appropriate for financial trends based on when the claim was paid rather than incurred.

Preventive Care: Preventive services include office visits, immunizations/vaccinations and lab tests.
